Model dies under suspicious circumstances in Bhopal : Muslim boyfriend leaves her in hospital and runs away

New Delhi A 27-year-old model died under suspicious circumstances in Bhopal. Her boyfriend left her in a hospital on Indore Road in Bhainsakhedi early on Monday morning. Doctors informed the police about her death. The police have taken possession of the body and started an investigation. A postmortem is being conducted at Gandhi Medical College in the presence of the woman's family and a magistrate. The deceased's family has alleged murder. Injury marks have been found on the woman's private parts, shoulders and face. Model Khushbu Ahirwar was very active on social media. She has an Instagram account called 'Diamond Girl', which has 12,000 followers. Khushbu used to frequently share her pictures while modeling on this account. Head Constable Pratik Kumar said that Khushbu Ahirwar alias Khushi Verma (aged 27) was in a live-in relationship with a man named Qasim. Qasim ran away after admitting her to the

hospital. Based on the information from the hospital, a case has been registered and an investigation has been started. According to the police, Khushbu had dropped out of school after the first year of BA. She had been living in Bhopal for three years. She had modelled for many local brands. She always talked to her mother about her desire to become big. She used to earn her living by doing part-time jobs. The deceased's mother Laxmi Ahirwar said that Qasim had called three days ago. He said, 'I am a Mus-

Supreme Court says- We are one country : Forcing people to speak Hindi, mocking lungi is not right, Kerala students assault case

New Delhi The Supreme Court on Tuesday expressed concern over the attack on two Kerala students in Delhi. The court said, "We are one country. Forcing people to speak Hindi and mocking lungi is unacceptable." During the hearing, the court referred to a recent incident in Delhi where students were forced to speak Hindi and were mocked for wearing the traditional lungi. This incident took place near the Red Fort. The Supreme Court said that the central government should take such cases of cultural

and caste discrimination seriously. A bench of Justices Sanjay Kumar and Alok Aradhe said, "It is sad that people are being targeted for cultural and caste discrimination in the country." Both the students were first-year students at Delhi University's Zakir Hussain College. They were beaten up by police and local residents. The court was hearing a petition filed in Delhi in 2015 following the death of Arunachal Pradesh student Nido Tania. The court had then directed the central government to constitute a committee, empowered to take strict action against caste discrimination, atrocities and violence and suggest measures to prevent such incidents. During the hearing on Tuesday, Additional Solicitor General KM Nataraj, appearing for the centre, said, "A monitoring committee has been constituted. Now there is nothing left in the petition." The petitioner's lawyer, Gaichangpau Gangmei, objected. "Incidents of discrimination and exclusion against people from the North-East are still happening," he said.

The bench said, "We have read in the newspaper that a Keralite man was taunted in Delhi for wearing a lungi. This is unacceptable. We live together in harmony. No one should be targeted on the basis of cultural differences." The court has passed several orders earlier in this petition. On May 1, 2023, the Supreme Court directed the central government to file an updated status report on the functioning of the monitoring committee constituted in 2016 to monitor complaints of racial discrimination and insults.
